### **BUYER AGREES TO THE FOLLOWING:**

1. This cat will be kept **indoors** and will be provided with love, good nutrition, and proper medical care.
2. This cat will not be sold or given to any pet shop, research facility, animal shelter, or similar facilities nor will this cat be abandoned!
3. It is Seller's intention that this be a permanent placement. If Buyer can no longer keep this cat, Seller will be notified and given first right of refusal. If Seller chooses not to reclaim this cat, it is the responsibility of Buyer to place this cat as a pet in an excellent home.
4. This cat is being purchased as a PET and will not be used for breeding. If this cat is not already neutered or spayed, Buyer will have this surgery performed before this cat is eight months old.
5. This cat is being purchased as a PET and will not be shown in CFA (or other registries) without the written consent of seller. (Seller hereby gives her consent: yes \_\_\_ no \_\_\_ HHP only \_\_\_ initialed by Seller \_\_\_) This cat may be shown in 4H (or other non registries) W/O Seller consent.
6. Seller strongly discourages having this cat declawed or having this cat's tendons cut!
7. It is agreed that if any of the above terms are violated, or if this cat is found at any time to be neglected or mistreated, that Seller shall have the right to repossess this cat immediately at Buyer's expense and Buyer shall forfeit the purchase price paid.
8. If there are other cats in the buyer's household, this cat must be quarantined until Buyer's veterinarian verifies that this cat is in good health; otherwise the following health guarantee is null and void.

### **SELLER AGREES TO THE FOLLOWING:**

1. Seller warrants that this cat is in good health, with no disease or parasites that seller is aware of. Seller recommends that Buyer have this cat examined by a veterinarian within 7 days of receipt. If, during this period, Seller is notified by Buyer of a health problem which existed at the time of receipt, Seller will replace with a of cat of equal value when one becomes available upon the speedy return of the (purchased) cat with a veterinarian's written statement of the health problem. Seller is in no way responsible for the cost of the vet check up or treatment. If this cat becomes ill or dies from any congenital defect, Seller will replace this cat with one of equal value when available upon written verification of said defect by a veterinarian.
2. This cat is vaccinated appropriately for it's age and you will be given it's health record when you take possession. I do not recommend use of the FeLV or ringworm vaccines. If the FeLV vaccine is given to this cat, all health guarantees implied of specific are null and void.
3. Seller will provide CFA registration paper for this cat after this cat has been neutered or spayed. Neutering or spaying should be done before the cat reaches 8 months of age. I cannot be held responsible should something go wrong with the surgery. If you have not contacted me by that time the cat is 8 months old with information about the surgery I reserve the right to reclaim the cat.

Non-refundable down payment of \$ 100.00. If buyer fails to pay remainder and take possession of the kitten within three weeks of being notified of it being available (upon receiving the third and last kitten) vaccination it will become available to the next buyer.
